1. Buyer understands that credit is extended only after verification of the entire Credit Application. All information must be given.
2. Jewelry only: 2% discount - 10 days / net 30; 7 days return on defective jewelry allowed with approved authorization number.  
Stones only: Net 30; due when purchased from memo, unless prior arrangements are made. All overdue memos are billed as sold.
3. No merchandise may be returned after 7 days of receipt without written approval of Columbia Gem House, Inc. / Trigem Designs™. A 15% restocking fee will be applied to all authorized returns after 7 days of receipt. (Stock balancing is available on a 3 to 1 basis for styles that have not moved after a 12 month period. These are not subject to a restocking charge. *Example: a \$300.00 purchase would allow a \$100.00 return of merchandise if it has not sold after 12 months.*)
4. All delinquent payments will be charged 1.5% per month interest and buyer agrees to pay any interest accrued.
5. Any payments received will first be applied to interest and then to principal due.
6. All sales final. Any failure to meet agreed upon financial payments will result in the entire balance on account becoming due. Any delinquent payments may result in the cancellation of credit extended.
7. If it becomes necessary to refer this account to collections the buyer agrees to pay all collection expenses, commissions and attorney fees even if no litigation actually takes place. In the event of litigation the prevailing party will recover attorney fees.
8. Applicant does hereby grant to Columbia Gem House, Inc. / Trigem Designs™ a security interest in and to any and all inventory sold by Columbia Gem House, Inc. / Trigem Designs™ to Applicant as a purchase money security interest on a first-in-first-out basis, as well as a security interest in any and all other inventory and equipment now or hereafter owned by Applicant for the purpose of securing any and all sums due and owing from Applicant to Columbia Gem House, Inc. / Trigem Designs™.
